THE CONDITIONS

- 2) The Customer shall repay QCC the balance shown as outstanding on each and every Account. - 3) QCC has the right to cancel the Account in its absolute discretion and without giving the Customer any prior notice and upon being notified of any such cancellation the Customer shall immediately pay to QCC all amounts outstanding in the Account together with any interest accrued thereon pursuant to clause 2 hereof.
- 4) QCC has the right to vary these conditions and any such variation shall become effective upon QCC notifying the Customer in writing of the variation.
- 5) The posting of a letter by QCC addressed to the Customer at customer's latest address recorded with QCC shall be deemed to be served upon the Customer on the date of posting.
- 6) All risk in the goods shall pass to the customer at the time of delivery of the goods.
- 7) Until QCC has received payment of all monies outstanding in the Account, property in the goods and services hereby supplied to the Customer shall remain in QCC at all times.
- 8) The Applicant/s warrants that he/she/they are duly authorised by the Customer to make and complete this application on the Customer's behalf and that the Particulars and other information herein provided are true and correct in every respect and further in consideration of QCC accepting this application at the request of the Applicant/s, the Applicant/s hereby jointly and severally (if more than one) guarantees to QCC that the Customer shall duly and punctually pay all monies payable to QCC in accordance with the within conditions. The Applicant further accepts liability for all credit transactions conducted on behalf of the Customer.
